

## Statement to churches in the Form of an Affidavit

---

We come to you as witnesses in the spirit [1John 4:2] as watchman on the Land [Eze:33]. Notice to Agents is Notice to Principals. Notice to Principals is Notice to Agents. Acquiescence is dishonor and sin.

1. A team of patriots has led a charge over decades to discover and reverse engineer the crimes and fraud against the living in the union of American States and put the pieces together to provide provenance and standing to object to the crimes and establish ourselves as lawful living men as fiduciaries in the standard of prudent men. Isn't this the golden rule and what Jesus reduced the Commandments to after our failure to live by the ten? The united States are the great experiment in self-rule without an intervening principal or "civil law" to separate us from our unalienable rights under God. Our Peace Treaties authorize our use of the terms sovereign, free and independent living men, but the corporations have scared us with the lie of "sovereign citizens". How can we be free slaves. This term is an oxymoron to any man or woman with more than a fifth grade education. We have been led astray and now the watchmen are making Notice of the crimes so that we can clean the mess and free ourselves not only from public slavery [14<sup>th</sup> Amendment of US Corporations] and bondage, but also of death in our contractual obligations made to the Father of Lies. **Most of our churches and Land holdings have contracts with Satan that are not necessary.** Our success in returning to the Land becomes a blueprint for freeing the world and revival to our faith. The path first required knowledge of the LAW [Land, Air, and Water] found in Genesis as the LAW of kinds. Jump off a cliff into the air and try to fly like a bird or breathe water like a fish and man dies. If we don't understand the LAW of kinds, we find ourselves contracted in the dead jurisdictions of the Water/Air. Legally [as opposed to LAWfully] we can be made dead by legal definition as we contract with Satan or acquiesce to contracts in our name likeness. Dead fictional contracts [like birth certificates/baptisms] in Air/Water actually place us in dead jurisdictions [by personage and lack of disclosure]. Our American founders knew the value of the Land jurisdiction [and living soil] and purposed to form our unincorporated government and freedom based on the signing of three treaties [LAW] ending the Revolutionary War. We are heir to the Land [Colorado], not a fictional royal estate [real estate] under the crown. We lost our way due to lack of education and faith. If your church is on a deed instead of a land patent, your church is incorporated, or you fly the war flag in your sanctuary, you like us have been trafficked by personage into the dead jurisdictions of the water and air. Let us help lead your people back to the living.
2. My wife and I are putting our skin in the game to reveal the truth to you under penalty of perjury. As watchmen, our employment is to bring you this message in faith. As the first maxim in commerce, a man is worthy of his wages. Let us help you transition back to the Land with our offering. Or accept dishonor and accept our lien through acquiescence. This administrative process is the watchman in practice. This Statement in the form of an Affidavit reveals the ten maxims in commerce. Since global [Air] jurisdiction and commerce are above all LAW, we must know the ten maxims in commerce. All living men and [wo]men are equal under our creator. Once we accept contracts that change our jurisdiction we become less than living man. We will provide donation to you to help rebuild your church. If you fail to accept lawful money of this Land, we will charge you as a false church and send you a True Bill for our labor. Since we have publicly declared our political status as living man and woman [common LAW married] on Fremont County Colorado [physical unincorporated] not the STATE OF COLORADO [intellectual property of the secular office of the Pope and Holy See], you must have at least one living man or [wo]man rebut every point of this statement in order to make lawful counter claim to our conflict. This is the basis of American Common LAW and the beginning of truth and full disclosure. If this seems completely foreign to you, it is because from the beginning of the birth of our country, Principals have conspired against us. Our Republican form of government by contract was replaced by mob rule [democracy] and a theocracy under the State of State [dead incorporation].
3. **The name America is based on the English translation and people as French Americans.**

a. *They were the original Authors of the principles that make men free; we were the happy beneficiaries of their long struggles against Ceasars, Popes and Kings. It all hinges on one exceptional idea: that one could be a member of a nation, and not be a citizen. That is, one could simply be a Frenchman, and owe no involuntary allegiance to a king – being a traitor to one's country. –Anna Maria Reizinger*

4. The LAW of kinds became the basis for international peace among groups of populations as nations. Treaties are written in LAW following Pope Boniface claiming Unam Sanctam in 1302. His world trust set up the Land to be protected by Land Patents or [allodial] interest managed by the King of Spain [Spanish LAW of the Inquisition]. The Roman Catholic Church claimed authority over the Air in global jurisdiction. The King of England was given authority over the Water in admiralty and maritime matters [as prince over the church Commonwealth Land, not over the sovereign barons of England]. If your church does not teach this, you are in a bubble [most likely lost at sea] with no access to your inherited rights on the Land [the corporate veil is the equivalent of separation from the Holy of Holies Luke 23:44]. If you do not know this, you will not cognize how your freedom has been stolen along with your wealth and labor behind your back in the higher jurisdiction of the air. While the great reformation split the Catholics and the Protestants, we failed to maintain offices in Air jurisdiction to keep our churches on point, make objection and educate with those with equal offices. The secular office of the church may have had good intentions of setting aside assets for those made wards of the State, but we have been made slave to the system and the storehouse has been overflowing cutting off its owners as we fight one another for survival. The presumption in LAW is that “legal persons” are less than those Principals with offices in Air jurisdiction.
5. The three treaties following the War of Independence created the agreements for freedom on the Land jurisdiction, payment for the cost of war [Tories, not Americans, had to pay back King George for his expenses], and peace with the establishment of three Constitutions [contracts for trust management organizations] in each jurisdiction. You probably only know of the Water Treaty of Paris. There is also a Treaty of Ghent [Air], and a Treaty of Versailles [Land]. The 1787 Constitution was a republican styled government for the people [state citizens] for our States of America [unincorporated] contractor. It was derived from the continuing Confederation of States business entity to act on our behalf in international jurisdiction with enumerated delegated powers. The 1789 Constitution of the United States was the Territorial delegation of powers to a Scottish corporation for essential enumerated services, like the navy, that the States did not possess. It was a lucrative contract used to pay back the King. Likewise, the 1790 Constitution [theocracy] set up the MUNICIPAL government with patent and post offices as the District of Columbia under the Pope. DC was supposed to host world leaders and us on neutral ground. These foreign for profit entities incorporated and are known as the United States and the United States of America. The title IV [Betsy Ross] style war flag was delegated to our **foreign for profit Federal contractors [Title IV]**. In contrast, our civil peace flag commissioned in 1779 has diagonal stripes and was flown in government offices until the Civil War [illegal mercenary conflict with no peace treaty to end]. The war power claimed allowed the foreign contractors to usurp the Land with Water LAW as pirates and claim our organic States of America contractor interregnum. This is why ware on poverty, war on drugs, war on terror... continue to be claimed. The corporate [foreign] Congress changed the definition of legal persons as dead corporate assets paving the way to making the living legally dead just like a credit card thief. The evidence of executive orders from the executive branch are evidence of private LAW of a corporation as the employees of the living employers on the Land [Article IV Section 4 promises us a Republican form]. Are you giving Caesar what is his or paying pirates to steal from you at interest? The tribute [Peter's pence] is theirs as long as you fail to recognize the truth that you were trafficked by personage at birth and converted to a dead legal asset of the British/Roman corporations. If you have Googled the ten maxims in commerce, you know how. Acquiescence to sworn affidavits in Water and Air vs Statements in the form of Affidavits [see disclosure in header] with living word as bond are made LAW with no objection. Ignorance of the LAW is not a valid claim. If there was no disclosure that you were unlawfully converted [personage is a capital crime], there is claim because Truth is sovereign. With Truth via full disclosure, one can object to the crime and make claim to return to living Land jurisdiction. We are bringing you the truth. You can object to our claim made from living Land/soil jurisdiction. Or you can become complicit in crime. Do you see how God's natural LAW of the watchman applies? We

have labored to bring you the truth. If you join the living with us, you can make counter claim to the crimes and enjoy your reversionary trust interest in the assets and credit that have been stolen from the living. Or pay us for our labor in this claim of unlawful residence on the Land. Dead fictions have no treaty to own Land [and cannot by LAW of kinds] in the united States on purpose from the founders we honor as “founders”. You have been made British/Roman Agents and failed to object to your death. Our churches failed to object as the overseers with offices in Air jurisdiction. Do you see why the offices in global jurisdiction must be maintained throughout the world. Are you on the rock of the Land? Or do you stand on fictions and have vacated your rightful office among the priests, pastors, and prophets as watchmen of our congregations of believers equal to all, directly under God?

6. The Land Patent is free of encumbrances and places the living directly under God without the civil LAW or any living principal to intervene, making men truly equal with unalienable rights as they stand on the Land/soil directly under God. Our founders understood that natural LAW without encumbrance would guide our leaders and allow non-Christians and atheists on our Land. Our unincorporated justices knew this and why we return to land jurisdiction unencumbered by contract [Cruden v. neale 2 n.c. 338 1796 2 s.e. 70]. The great commission was supposed to spread life in love and abundance, showing the value of commitment to Christ through our acts of faith. Instead, Christians contract with Satan and use write-offs of unLAWful income tax to dumb down our faith built on contracts of lies. Our churches make real [from word royal] estates and incorporate to offer deductions tax exemptions to a voluntary tax program for Federal employees of the corporations. This is not necessary if you do not contract with the corporation. This is why they want to convert you with a birth certificate. We find comfort in being “luke warm” in our faith. We do pay for delegated services as a sovereign People, but we owe pennies to their quadrillions stolen. This is why many denominations choose to be all inclusive without standing on the premise in Acts 2 where the new disciples were to wait on the gift of the Holy Spirit to come and be witnessed by the speaking of tongues to all. Do we all stand arms interlocked in peace around our church grounds and allow the Holy Spirit to heal the sick or do we acquiesce to the zoning authority that makes us paint handicapped parking spaces in our lot in a subdivision? Return to the Rock and there are no carrots to dangle over you.
7. We know that the brain is hard wired to hear our own voice so sports psychologists encourage athletes to vocalize positive things to themselves because it literally improves performance. Faith comes by hearing. What part of “all” do we not get? So to accept the gift of tongues but not require it of our disciples is a short coming in providing an act of faith that has physiological benefits. Everyone that can speak can use their private prayer language to speak with God audibly (or rely on Romans 8 silent murmurs without the power of hearing your own private language). It is not wrong to allow the congregation to act in faith without the gift of tongues, but it is like pushing a car down the road instead of filling it with gas and using the multi-horsepower motor of the Holy Spirit. Can we renew our faith with just the gifts from God? We are not here to tell you how to run your church or establish your articles of faith. We are here to ensure that at least one American stands for your entity claiming to be a church. Only living Americans can own Land.
8. The Land is meant to be yours and never taken away as fortified by treaty and Constitutions by Americans that literally laid down their lives for this claim [Google ten maxims in commerce]. If you know this, why would you grant a mortgage fiction or foreign government services contractor the right to take it away for lack of payment? Even more important is the lack of education by our schools and churches to know the information presented in this Statement to preserve your unalienable rights under God and pass it on to the next generations. Quadrillions in wealth and assets have been secured away because the inheritance has been withheld from legal persons declared dead by the employees. The living, not fictions, own all the assets and credit. It has been hidden by a lie. The global accounts and vaults hold enormous wealth that was simply waiting for LAWful claim to the truth. The withholding is a gross breach of trust against the employers [living] to make us slaves to the debt [see 14<sup>th</sup> Amendment] as dead assets of the corporations. As just one example in double entry accounting, like used by the US Corps [after Al Capone’s accountant], every debit must have an equal credit. Thus, for every dollar in national debt, there is an equal offset entry in credit. Did you pass algebra? Do you know about the secret Treaty of Verona and why the Pope and banks have been holding our credit accounts hostage for over a century [they were waiting to make lawful claim after declaring us lost at sea for over six generations]? **Would you like to learn about the trade bank [<https://Global528.com>] for living on the land and gain access to your credit held**

from your family for the last six generations? Although the last steps to convert American Federation Dollars, AFD, to Federal Reserve Notes, FRN, is pending, those on the land are currently receiving 5k AFD per month for reparations. Shouldn't this news come from within the church? Do you see why a breakdown in the Watchman process subjects us to bondage? Imagine our power to stand together against the Crown and Pope [secular office] to demand our inheritance if we restore our living standing in Land jurisdiction. By maxim in LAW of last man standing, we have Assemblies in fifty States and have been recognized by the Vatican Chancery Court with over 500 pages of claims being processed and trillions in liens alone. Will you stand with us as Americans or be complicit after knowing the truth and stand as converted British Romans trespassing on American soil? Take a minute to research lawful instruments and know that the IOU as the FRN is not even a LAWful instrument with no date of payback. Our claims have been curing for decades and now it is time to stand for American Common LAW and the treaties our founders signed to preserve unalienable rights. Will you put your objection of genocide and trafficking babies into bondage as humans on the record?

9. The living are dependent on all three jurisdictions. We breathe air and proclaim faith to live. Water fuels our cells. Life is on the top five inches of soil that comprises the Land and gives us energy to live. The Land connects us to the other dead jurisdictions of Air and Water. We arise from the dead jurisdiction of Water in our act of baptism into life and into Christianity. It is our relationship with God that allows us to convert from dead to living. We are born in water as sin and shapen in inequity [Psa 51:5] into living men and [wo]men heir to the Land [Rock] and subject to God of the Air. We get out of balance when we are taken from the Land/soil into the Air/Water by international crime of personage [Territorial and MUNICIPAL corporations]. Satan does this by tricking our parents into signing birth certificates as contracts just like the original sin found in the Garden of Eden. The crime is failure to disclose that we are taken from our inherited rights on the Land and placed in dead jurisdictions of Water by an estate trust by the Crown. Seven years later when we make no claim to the estate created in the likeness of our name, we become wards of the Pope in Air jurisdiction by the Cestui Que trust. By LAW we become British Romans by our failure to object to the fraudulent contracts. If your churches had trained us of these truths, we would only need to put the births in our Bible and publicly announce are co-creations in our churches. Why did we involve British and Roman corporations in our private family matters? Why do we require licenses to marry? Why didn't our churches object to this practice that violates Hague and Geneva conventions. We sing our praises to God, but do we raise up our hands and object to the work of those that would make us dead by contract?
10. Written contracts and incorporations [legal dead fictions] are the intellectual property of the Pope [secular office] and are administered in the Ecclesiastical Vatican Chancery Court by the treaties formed to promote peace on the planet by tradition and treaty for world peace. This is the uniform commercial contract [UCC] code adopted by our Territorial and MUNICIPAL contractors as well as their subcontractors [STATE OF STATE] as chartered corporations. Without oversight in Air jurisdiction, we were tricked into the need for birth certificates by [dock]tors [Water jurisdiction] and our mother's wet stamp to put our name into a commercial trust. This tradition is based on the claim that the afterbirth was thought to be living and the birth canal an inland waterway. We have come a long way in our knowledge of physiology and medicine but the tradition and failure to object has led to crime that is no different than a credit card hack. This is part of the secret plot to intervene in our land ownership [Treaty of Verona, 1822, American Diplomatic Code, 1778 – 1884, vol 2; Elliot, p. 179 and CONGRESSIONAL RECORD – SENATE., 64th CONGRESS, 1st SESSION, VOLUME 53, PART 7, Page 6781, 25 April 1916, in which the Higher Contracting Powers agreed to undermine the American government]. They literally hired an entertainment group [BAR members] in England to criminally lead us astray. Replacing our middle name with a letter or putting our name in all capital letters [DOG-LATIN] confirms the transition to dead by style conventions in LAW. This went on until the Motu Proprio issued to make attorneys and fictions accountable in 2013. They were given years to comply and now there are multiple claims on the court for liquidation of many offending corporations. If you do not join us in objection, you become complicit in the crimes and a barrier to abundance. Our truth is to help you realize the claims in international and global LAW that have been made and cured. We hold them accountable in peace in LAW or we continue our contracts with the Father of Lies. I am told an administrative letter was put out by the Navy July 27, 2023 indicating our courts are to return to International Common LAW and Constitutional rights. You cannot share in these rights as long as you are human and labeled a slave with British titles like Mr. or Mrs.. If our parents had been told

that they were making their babies public slaves as dead assets [legal persons] and indentured to debt in the 14<sup>th</sup> Amendment as a contract with Satan, would they have signed? Every contract we enter in Air/Water confirms our agreement to be ruled by Satan in dead jurisdictions. Meanwhile our churches sign contracts in Air jurisdiction to incorporate and give British/Romans deductions on Peter's pence. It was a lack of faith and lack of education to stand on Land that gave Satan power to entice our pastors and elders to contract with lies that formed our churches as fictions on top of fictions separated from the Rock. Our church leaders were either afraid or uneducated that they could not live the God model and needed the enticement of exemptions to make sure there was enough money to fund church needs. If your church has no provenance to the splits through the Reformation, you have no seat at the table. In your attempts to reach out to God with faith, you ignore your standing on fictions and ignore the importance of having a seat at the table in Air jurisdiction to make stand based on established LAW. Why do our churches need a contract with any King, Pope, and/or Satan to serve the living? Where is the treaty that allows dead assets or fictions to own Land in the united States or force us to contract with the King or the Pope? Our objection is to the living men acting in office of Air jurisdiction to deny our rights and claims by agreed upon LAW. Over five hundred pages have been submitted to the Vatican Chancery Court with thousands of supporting articles. Where do you stand? What do you know? What will you do?

11. Our American Common LAW centers on contracts to block the government from our natural LAW rights. The government corporations administer admiralty/maritime as private corporate law. We have been under martial LAW since the civil war, by evidence of the war flag flown above public [actually corporate] buildings and their declaration of us as missing and interregnum. History of no declaration of war by a Land jurisdiction Congress and no peace treaty to end said war mean the Civil War was not a war, but rather a mercenary conflict under merchant LAW. Where was your church or its predecessors to object? The act of assuming all authority over the Land was and is a continued act of piracy by foreign for profit contractors that are no better than credit card thieves using tricks by BAR members to circumvent our American Common LAW [see 6<sup>th</sup> and 7<sup>th</sup> Amendments that guarantee Land LAW]. By international LAW, piracy does not change ownership. Any government can prosecute pirates. Now that we know, we can establish proper standing and provenance to object and make lawful claim through peace and LAW.
12. Our founders used the LAW of kinds to make sure that we could be free on the Land with no encumbrances. We simply treat others equally with no harm. This works until someone is hurt and then we must apply LAW to the broken peace/conflict. Our Land jurisdiction was supposed to be rebuilt after the Civil War conflict. President [really CEO] Lincoln appeared to repent and wanted reconstruction. Were you taught that he was assassinated as a result? Where is the completion of reconstruction of the Land jurisdiction? Are we misidentified as Romans and Tories and pay tribute to foreign corporations?
13. Anna Maria Reizinger [<https://annavonreitz.com>] and team have taught us how to use existing American paperwork to reverse engineer the crimes against us and return to the Land/soil to receive our inheritance from God. The 1779 Naturalization Act that distinguished between Tories and Americans [we look alike] that was used after the War of Independence can still be used to state our political status. We simply wet stamp our declaration and publish to Notice our intent to return from the dead as living men and [wo]men on the Land/soil. It would not be necessary but we have agreed to the crimes by every document we wet stamp with a name in international commerce. Our names are important and we claim back the living name given to us by our parents and not the trusts that were assigned to our afterbirth. Our English language uses the Land jurisdiction name in lower letters like michael leigh macgowan [appellation] to present me in living soil on the Land. My international Land jurisdiction [dead] name that can be used in commerce is my name in camel case, Michael Leigh Macgowan. This is opposed to the trust and utilities set up as identities to steal my inheritance as a usufruct. Slave names are written in upper case, Parse Syntax, and/or DOG-LATIN conventions to denote fictions. Since you don't know, you don't object. Michael L Macgowan and MICHAEL MACGOWAN are vessels and/or dead corporations used to identify me by the subcontractors doing business as the U.S.. Can you see how the world around us forces us to contract with Satan in Land/Water with names that are not the living man? Remember these corporations are bound by Constitutions as contract agreements and are chartered ultimately under the British Crown and Pope as Principals. ***They are for profit foreign corporations providing essential government***

**services as employees to the living as their employers?** Will you have more rights as an employer or an employee when you know the truth? Realize that this Notice is on the record and you must act or be recorded as complicit in the crimes. It is your choice. By our captioned Notice, we will either gift you in your pursuit of truth or charge you for our labor to establish the truth on the record.

14. State Nationals publicly declare their right to return to the Land/soil as inheritance and return to the Land/soil jurisdiction. But we physically stand in a Land/soil bubble around ourselves because our residence is encumbered with layers of Satan's fictions. The next step in reverse engineering is to remove the pirates of Air and Water that have come on the Land/soil offering us taxes and residence instead of unencumbered [allodial] interest. We must return the land itself back to the Land/soil jurisdiction by declaring our interest [various titles with inferior interest to the Crown] in those legal portions of the Land we have by our chains of title that should stand as LAWful interest under Treaty instead. We make use of these chains and make public declaration back to the Land Patent issued under the treaties set up by the world trust described above. If you research your own chain of title, you will find that the original transfer was based on a Land Grant and eventually we ended up with deeds and zoning as part of the Justinian deception [Babylon]. This way we go back to granting our heirs [allodial] interest in the Land. It cannot be taken from us and is protected with the promise of other nations by treaty. State Nationals are protected from the government contractors by Constitutions. In contrast, legal persons are treated as dead assets under the LAW of war and private statutes of foreign corporations.
15. Jesus said he would build the church upon the cornerstone of Peter. Where is it written that our Land and churches must be built with bricks from Satan on top of the stone? The Catholic [universal] Church in its secular office formed the very fictional entities of serving the dead that allows the Air and Water jurisdictions to contract the living into the dead jurisdictions of the Air/Water by the Agents that attorn for the dead as "attorneys". Bankruptcy [not possible in Land] allows the entity to be dissolved and the assets are sold for pennies on the dollar to creditors. A bank may have interest in the building on the Land but not in the Land itself. You are on your word to honor repayment as your bond. Whether they had money to lend you is a different question. Now that we have knowledge of what has happened, we can remove these contracts and return to the Land without fear of reprisal from any Principal or entity. We stand directly under God equal to all other Principals and above the fictions. See why they want you to become a fiction? Ironically the dead cannot pay back promises for payment. The only contracts that are necessary are those we make with God. The good news is that using last man standing and exercising our right to assemble, we have stood up unincorporated assemblies in all fifty states. This provides standing to be heard by the Pope, allowing us to have our bonds removed and to free the assets that have been kept from us. We did not have standing for a century and a half as Dead legal persons. This time it is the remnant of Israel that is the victim of the theft [Jacob, the supplanter have I loved and Essau have I hated].
16. Our church[es] was supposed to spread the Word of God as the Great Commission. Life under the direct authority of God is to show us that acts of faith bring us into the community and allow us to receive love and abundance. We learn and experience this model through churches and ministries. We also learn in our hearts how to behave by speaking our prayer language and elevating our brain circuits by hearing our direct prayer language to God. This working model is the template to show nonbelievers that faith in Christ is the answer. We live as fiduciaries in the standard of prudent man doing no harm to others.
17. Rather than walk in faith, the church has divided many times and lacks the faith to function in the original model. Our fear has made us susceptible to contracts with Satan. How many times will we eat the forbidden fruit? It is the fear of providing for the family that has given rise to a need for incorporation(s) that can go bankrupt and distribute the losses to the public. Ironically, the communism model is based on making all things common per need in Acts 2:43 but without the necessity of a contract with Satan or having a civil authority standing between men and God. We didn't trust God's plan. **Our conflict with you** is that you have not identified yourself publicly as a living Christian man or woman and have no Land Patent to stake your claim as owner on Land jurisdiction under Treaty/LAW of this Land. If no one in your congregation makes living claim, we will present you with a Lien as a True Bill to bring the truth forward as this is our labor as Watchmen after Three Notices. Since all conflict requires a resolution at LAW, the final option in commerce is to pay the lien. Three Notices is sufficient to complete due process in American Common LAW taken arising from the

Biblical principal of three gathered in my name. We present these truths so that you can clean your house, claim your Land and your status as living men and women without contract to Satan through LAWful access to the living Land/soil.

18. More concerning is the trade of souls for compensation. Does your church keep its copies of or create baptism certificates? History shows division of the universal church due to the accusations that it was engaged in practices like selling souls on the black market. If your church keeps record but does not have originals, they may have been knowingly or unknowingly used in black magic. Why would you give wet seals of the living to any entity?
19. Our education is to blame. Our contractors took over education and our media while our churches failed to object. We didn't even know that every nation has a war flag and a peace flag. Why do we fly the war flag in our sanctuaries? Are we telling God we are at war with Him? Does it make sense that there are always two flags to distinguish between our war ships and our private merchant ships at sea? When a war is ended by peace treaties, shouldn't we identify ourselves with the peace flag? Shouldn't we object to the guise of "war" on poverty if there is no declared war by the Land Congress with the authority to declare a State of War? How do you welcome the return of Christ while you identify yourself as an entity of commerce under war?
20. We domicile as living in a State [nation] rather than a State of State [STATE OF COLORADO]. In trust LAW, the preposition "of" can mean without or non-domestic to the Land jurisdiction. So the STATE OF COLORADO is really the incorporation of the dead in Air jurisdiction as a bubble of air on top of the Land. When our land jurisdiction Confederation of STATE OF STATES went missing, our STATE OF STATES were replaced by British STATE OF STATES. The British and the Romans then colluded in their Declaration of Interdependence to further confuse us from knowing which contractor we are submitting to. Does your church have a 501 c 3 or a corporate charter? You become a Christian and/or member of a church of Satan without the disclosure of which entity and jurisdictions you are being committed to. If you now know the truth that you have contracted with Satan and have become a dead corporation, what will you do? Since there is no statute of limitations on fraud, you must act to make objection on the record. To contact me, you have to be willing to object to being less than man. In the alternative, your acquiescence will be recorded as a fraudulent representation of the Christian faith by a secular chartered fiction. The maxims in commerce established for thousands of years and hidden for a century and a half now determine your intent. You cannot unknow the truth. You will be dissolved and your Land given to us as payment for our labor if necessary. We are the only known living on Fremont County and make this claim in order to restore the living population. But you have to act and put your skin in the game to join in the claim. We welcome walking with you as equals under our creator. Will you join?
21. Do you serve God or Satan? Are your fruits founded on the Rock?
22. God is the Alpha and the Omega. He judges our intent. We get credit for our acts of true faith. We have a new responsibility now that this truth has been presented. Ezekiel 33 [watchman notice] is a fundamental tenet of American Common LAW guaranteed by the Constitutions the Federal subcontractors are under. Notice to Principals is Notice to Agents. Notice to Agents is Notice to Principals. It is your responsibility to act now that you have been Noticed the truth. Acquiescence is dishonor. Will you clean yourselves of the contracts that separate you from God? Will your church return and stand on the Land and offer baptism without encumbrance to Satan?
23. Notice is fundamental to American Common LAW. Three un rebutted Statements in the form of Affidavits stand in American Common LAW [Land] and maxim in commerce [Air] and complete due process[2 Cor 13:1]. This is directly from two or three witnesses from Mathew 18 among many affirmations of the power of witness in the Bible. Such Statement like this must have every point rebutted or stand in LAW by sovereign, independent, equal and free living men and [wo]men. The third Notice is a last chance to refute receipt of the first two Notices or like the watchman, take on responsibility [sin] for not acting or blowing the trumpet for others to hear. You have been called. **This is at least your first Notice.** We will publish this Notice as presented to your church on Combolisk.org [our effort to broadcast the truth in the tradition of Paul Revere]. Our expectation is that you will hear the voice and pass this Notice on. If we do not hear from you, we will pass the Notice to your members as sheep that hear the voice to complete second witness. Realize that if we ask a member of the church whether they heard this message, your sin may be exposed. Leaders in sin and collusion with Satan should be replaced with believers in faith and establish right standing with God and the Land. If the

members fail to ask us for help or respond to our Notice, we will pass judgment and complete due process with a Lien/True Bill presented at Third Notice. The Record is going forward as we have been called as Watchmen.

24. A prophet acts under 1 Kings 13 by putting skin in the game. James Clinton Belcher learned on his mother's death bed that James was heir to the provenance of the American unincorporated Federation of The United States. She admitted that his father had given up but that they could take on the burden of standing under persecution from the corporations that wanted them dead. James and Maria responded by trying to get audience with the Pope who denied them standing as humans. They in turn used the Spanish LAW of the Inquisition and Last Man Standing to make their claims under likely death sentence as heretics. Instead they became gods [not The God but equal to the Pope and over sovereigns]. They asked for and received the Motu Proprio of 2013 ending the BAR letters of marque to usurp our Land jurisdiction. Multiple claims have been curing including a 297 trillion lien against the BAR associations and DOJ. Join in our effort to collect. There are more of us than Popes, Monarchs, Generals and bankers put together if we stand united.
25. We believe a revival is coming to the church as we take back the Land and get rid of our unnecessary contracts. Our churches and the Lands they set on is the cornerstone to the artifacts of our history. We may be divided in our beliefs about how to interpret the Word of God, but we cannot deny the historical relevance of our existing contracts. We can declare our political status and move back to the Land and restore the [allodial] interest in our Land. Only living men and [wo]men can do this. Torries are foreign principals allowed on our Land by the Residence Act without [allodial] interest. Dead entities [including legal persons] have no right to be here [treaty necessary] and they have used the guise of war and declaration that we were interregnum to validate their claims even though James and his predecessors have been in hiding all this time. The good news is that anyone can receive the gifts of God on this Land, as designed by our founders, as Christians respecting the LAW of kinds. The big question remains as to whether we need to restore our churches to unencumbered status and renew our baptism without intervention of Satan. We have been baptized on Land/soil with no encumbrances, we can bless water and bring other Land into the mix by dissolving incorporations and allowing our churches to stand on the Land by Land Patent. Do you remember how God insisted on clean sacrifices without blemish throughout the old Testament? **Imagine if we now, as nations of States, stand and renew our faith and pray out in our direct tongues to God on contract free clean land!** Can we clean our Land of unnecessary contract, publish our status as living by objecting to the crimes of personage and live in abundance?
26. It is clear that six out of the seven churches found in the book of end times, Revelation, are in need of repentance. The Philadelphia Church is presumed to be free of contracts with Satan or any encumbrances to dead entities and the only church that is not in need of repentance standing in faith. The united States is long thought to be the leader of the free world with its unencumbered seat of unincorporated government continuing to be in Philadelphia. The name is not accident. It is the District of Columbia where our unincorporated Congress was supposed to meet with our Territorial and MUNICIPAL contractors and other world principals to meet on neutral ground. Regardless of whether Philadelphia represents the church in faith, it is the Assemblies of the States that have reconvened and are rebuilding our Land/soil jurisdiction. If we all had faith to stand as the living, there would be no need for the Territorial or MUNICIPAL governments, especially if our assets and inheritance are returned. In the least, we force them as employees to be bound to their service agreements or fire them and hire new service providers.
27. The Catholic church has tried to do many things right by setting up a system to care for those left behind, but money and power led at least the secular office astray. As the world grew larger, they needed an office to manage affairs and hired subcontractors that were left without adequate oversight by our churches. Pope Benedict assigned the secular office to now Pope Frances. The ministerial office of the Pope appears to have died with Pope Benedict who was repenting. The secular office of the Pope was closed leaving the question of what office Pope Francis now holds given that he is a Jesuit. Jesuits are defined with oaths to serve the Pope thus negating the chance that Pope Francis holds the ministerial office. The only office remaining for Air jurisdiction is that of Prince to Satan but looks as though Francis has reunited with the Orthodox church to take on that office. Who will make him accountable to the claims that have cured? What is your church doing to preserve the living interest of our land and unalienable rights? Lawfully they don't exist if you are human and only exist under dead civil rights. You must exist as living under God, standing on land, living on the soil.



28. If you would like help in restoring your Land, please contact The Colorado Assembly [TheColoradoAssembly.org]. I am a recorder so I can help with paperwork. If you would like to be baptized without encumbrance, we have claimed Land Patent on our Land just outside Florence. We live in an RV and haul our water from Florence but would be happy to have you step on clean Land with clean water to renew your faith. We would be happy to baptize you on our clean Land but our facilities are humble. As you reclaim Land jurisdiction and gain Land Patent to your unencumbered churches, please send Notice to me at Combolisk.org so that I may publish your status in our claim of unrestricted outdoor free speech in the tradition of the outdoor broadcast operator, Paul Revere. Please don't let this Notice be a record against your lack of fruit. Let our churches be the first to rebuild the model of faith without the specter of death's contracts so that we can work together to revive the dead to living jurisdiction and clean our Land.
- a) As action items, everyone Noticed must pass this Notice to Agents and Principals so that all effected become aware. Please also Notice us to avoid our Second Notice [attached] to your church by handing out fliers to your members. Your Notices will be recorded on Combolisk.org. If we have not heard from a living man/ [wo]man or legal person attempting to return to the Land as living within thirty days of Second Notice, we will shake the dust from our feet and mark your church as lost and dead with no living men or [wo]men representing interest in the Land. **Your Land and assets will be marked for claim by the living.** Foreigners are only allowed in the united States by the Residence Act. Legal persons and fictions have no treaty to own Land. The creation is not greater than the creator [the righteous are as kings and queens sharing in the mind of Christ].
  - b) All fictional entities must have a living man or [wo]man responsible for an entity residing on the Land. A memorandum from your corporate board can assign an Agent to return to the Land/soil or you can choose a living Principal. By default your Principal is the Pope. Your corporation and assets may be taken by trespass if you do not have an American State National or State Citizen as Principal making claim on your organization's behalf if you wish to remain a British/Roman charter. Your contracts are your business but we believe God is leading us to clean house. Will you renew your baptisms on Land? Will you confirm by the Holy Spirit? We would love to help.
  - c) We encourage all churches, denominations and non-denominations to assemble in peace. How long will the enlisted and all those enslaved under U.S. Citizenship stand for being paid at or near minimum wage when millions are owed to each? This news is yours to stand on or reject. It doesn't matter if it takes us a year or a thousand, the Truth will prevail.
  - e) We will make an offering of 50 AFD to your church at Second Notice if necessary. This is lawful money. If no living man claims it on behalf of your charter serving your God, the offer expires and we will make the equivalent claim of \$12,000 FRN for our labor to bring you the truth. We object to the use of FRN but will accept it under duress until our vendors have access and utilize AFD or equivalent assets from the Land. The FRN has been used to commit genocide and is military script, not a lawful instrument as it has no payment date. At Third Notice, due process has been complete and your only option is to pay the claim. In order to operate in commerce, you must have a bond. See my Writ of Habeas Corpus at Combolisk.org for more information.
  - f) Control your autograph and contracts. Your wet stamp is your agreement. If you contract, keep an original and know that any other originals or duplicates are controlled by trust. All rights reserved. Acquiescence is agreement as well. What will you do now knowing the truth?

- g) Your flag shows your intent. If you fly the war flag upside down, you are in duress. If you fly the civil peace flag, you, like us, are at peace. Now that you have been told these truths, you are the Watchmen. What will you do?

- i) Second and Third Notices are attached for your review and full disclosure if we need to progress through due process.
- j) We plan to donate 50 AFD in your collection plate. If no one claims this as an American on the Land, we will claim the same value back as an equivalent in FRN as payment for our wages as watchmen. Since FRNs are negative numbers, one silver dollar is greater than all FRN ever produced. By our remedy at LAW we claim 250 FRN to the AFD while under duress.

## Statement to churches in the Form of an Affidavit [Second Notice to Congregation]

We come to you as witnesses in the spirit [1John 4:2] as watchman [Eze:33] on the Land. Notice to Agents is Notice to Principals. Notice to Principals is Notice to Agents. **Acquiescence is dishonor and sin.**

1. Patriots [some with provenance to the unincorporated Federation of The United States] have led a charge over decades to discover and reverse engineer the crimes and fraud against the living in the union of American States.       3. Treaty of Paris [Water] the King of England is the Prince [#2] of the Commonwealth for the Pope
  - b. There are three Constitutions to the united States to delegate enumerated authority from the sovereign States
    - i. 1787 The Constitution for the united States of America 1787 organic from confederation of states
    - ii. 1789 the Constitution of the United States of America 1789 Territorial contractor [Scottish corp]

  - c. Every country has a peace and war flag to distinguish war vessels from innocent and noncommercial targets.

If we do not receive a response from you, our Third Notice will complete due process of this presumed for profit foreign corporation chartered by criminals without LAW to support ownership of the Land beneath the church. **You are called to Act**. If you do nothing, our donation of 50 American Federation Dollars will become a Lien\True Bill [Third Notice] for \$12,500 as there is no evidence of fruit on the Land by a presumed chartered religious entity by foreign contractors US/USA. Fictions and foreign Agents have no treaty to own land.
3. **The name America is based on the English translation and people as French Americans.**
  - a. They were the original Authors of the principles that make men free; we were the happy beneficiaries of their long struggles against Caesars, Popes and Kings. That is, one could simply be a Frenchman, and owe no involuntary allegiance to a king – being a traitor to one's country. –Anna Maria Reizinger.

# Statement to churches in the Form of an Affidavit/Certificate of Dishonor Lien/True Bill [Third Notice to Congregation and completion of Due Process]

---

We come to you as witnesses in the spirit [1John 4:2] as watchman [Eze:33] on the Land.

Notice to Agents is Notice to Principals. Notice to Principals is Notice to Agents. **Acquiescence is dishonor and sin.**

This is a Statement in the form of an Affidavit:

- 1 First Notice was presented to at least two leaders of your church as Word from God regarding crimes committed against you as living men and women. By deception and generations of planning, the King and secular office of the Pope conspired against the living men and women to steal all the assets and credit of the living leaving us worthless paper engraved images in Federal Reserve Notes [I.O.U.] as unlawful instruments without a payment date.
- 2 We provided Notice of the process of unlawful conversion as personage that begins with converting the living to dead jurisdiction of Water and then to Air jurisdiction to steal and subject the living to Civil LAW under dead fictions. This includes taking away our allodial interest in the Land free of encumbrances. Our treaties don't provide for fictional entities or foreign corporations to own Land based on Genesis LAW of kinds. Only Americans can own Land. Our forefathers knew we had to keep our Land Patents and protect us from foreign fictions. They autographed treaties to protect us but had to compromise with foreign Principals to cover losses and provide remedy for foreign residents and their interests that remained here after the Revolutionary War. These interests evolved into foreign for profit essential government service contractors. Those contractors conspired against us.
- 3 We made suggestion to return to living Land/soil jurisdiction and to removed royal interest in the Land so that our churches can hold their offices in Air jurisdiction and object when LAW is violated. Failure to object as Christians violates the requirement of the living as prudent men. You have failed the golden rule are are complicit in crime. The failure of those previously Noticed to all within your congregation is evidence of your group sin.
- 4 When your leaders failed to follow the most basic maxims in commerce by rebutting each point of the Notice or at least spreading the Word, we Noticed at least two more members of the congregation with Second Notice. Their responsibility was to rebuke the Noticed leaders for failure to spread the Word as required by the basics of American Common LAW and Biblical maxim of the Watchman. Have you read of the remnant that always moves forward in righteousness? How can you be righteous with no foundation on the Rock?
- 5 As part of Second Notice, we made offering of 50 American Federation Dollars as first donation of real lawful money of this Land to help your congregation start cleaning. It is proof that the American Federation of The United States of America is finally rebuilding with standing and provenance to the artifacts and treaties that give us sovereignty in our own right. We are kings of our own castles equal to the Kings, Pope, and Principals of the Word. The donation had to be claimed within thirty days. If all those living as victims of personage stand in faith, the criminals must return our credit and assets by the LAW that exists. We just need to stand in faith. Your group has provided no American to stand with us.
- 6 Since no victim has come forward to claim intent to return to the living Land/soil and represent the congregation, we now present your entity as dead, with no fruits, as a foreign chartered for profit business entity with no value as chartered as a nonprofit religious institution. You have no right to own Land in Colorado as the claims by the corporations invading the Land have no lawful authority to do so. The record has been recorded on Combolisk.org.

- 7 Our Labor to present the truth is 50 AFD we were going to donate to you. This is now due as this Lien/True Bill with your Certificate of Dishonor. Although we object to the use of Federal Reserve Notes [unlawful and used for genocide], we will accept Federal Reserve Notes under duress as your only form of payment under requirement of commerce. A man is worthy of his labor by international maxim established for thousands of years. By Lien/True Bill, you owe us \$12,500 Federal Reserve Notes or 500 ounces of silver. Payment must be made within fifteen days or we add collection fees of one ounce of silver per day plus the cost of collection for costs associated with collecting the value of the Lien/True Bill. Your entity is subject to dissolution and sale to cover the costs of the claim. Piracy does not change ownership. Fraud vitiates everything it touches.
- 8 Our purpose was to educate and bring you the good news. We have been led to bondage and scarcity by the unlawful adhesion contracts that were attached to our afterbirth. We didn't know that the usufructs created in the likeness of our names would be used to bind us by contracts into dead jurisdictions. Since we were not given the truth by full disclosure, it is our responsibility to undo the things that have been done to us and live as fiduciaries in the standard of prudent men. So it is done; so it must be undone [maxim in LAW].
